

Influent Pumps at
Wastewater
Treatment Plant

Macon Municipal Utilities is requesting bids for the installation of three (3) fifteen (15) influent pumps and associated check valves, shut off valves, and controls at the Wastewater Treatment Plant. Bids are to be delivered to the MMU Business Office at 106 W. Bourke Street, Macon, MO 63552 by 5:00 pm on Friday, October 9, 2020.

Successful bidder must purchase a City Business License. This License may be obtained from the office of the City Collector located at 106 W. Bourke Street, Macon, MO. 63552. The fee is \$50.00.

Successful bidder is requested to carry insurance coverage for the duration of the project in the following amounts. Lower coverages may be accepted.

- \$1,000,000 Liability
- \$2,000,000 Aggregate
- \$5,000 Medical
- Workers' Compensation

The successful bidder will be required to provide a certificate of insurance listing Macon Municipal Utilities as <u>additional insured</u>, and sign a hold-harmless agreement. Successful bidder shall require same of all subcontractors. Each bidder must inform himself fully of the conditions relating to the composition of the project and the employment of labor thereon. Failure to do so will not relieve the successful bidder of his obligation to furnish all material and labor necessary to carry out the provisions of this project.

Submission of bid confirms bidder agrees that they understand, and agree to abide by all terms and conditions, responsibilities and specifications of the project. Bidder will be presumed to have inspected the site and to be thoroughly familiar with the project requirements. The failure or omission to do so, shall in no way relieve any bidder from any obligation in respect to his bid.

Bidders are informed that pursuant to Section 285.530, RSMo, as a condition of the award of any contract in excess of five thousand dollars (\$5,000), the Bidder shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection to the contracted services. Bidder shall also sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection to the contracted services.

This project is <u>not</u> expected to be subject to **prevailing wage** rates. No work is to commence until the Contractor has completed the required paperwork with Macon Municipal Utilities. MMU will negotiate a firm completion date with the selected contractor according to schedules of when

the work can be performed. The contractor shall pay liquidated damages to Macon Municipal Utilities of \$100 per day, or portion of day, for each consecutive calendar day thereafter.

Once work has commenced, the work shall be continuous and the contractor shall not remove their personnel and/or equipment from MMU until the work has been completed and approved by MMU.

The bidder's attention is directed to the fact that all applicable State Laws, Municipal Ordinances, and the rules and regulations of all authorities having jurisdiction over composition of the project shall apply to the contract throughout, and they will be deemed to be included in the contract the same as though herein written out in full.

MMU shall be the final judge of the quality and suitability of the work, materials, and methods of construction for the purposes for which they are used. Should they fail to meet approval they shall be forthwith reconstructed, made good, replaced, and or corrected by the contractor at his own expense. Rejected materials shall be removed immediately from the site.

MMU reserves the right to reject any or all bids.

SPECIFICATIONS

Macon Municipal Utilities is requesting assistance with the installation of three (3) fifteen (15) horse-power influent pumps and associated check valves, shut off valves, and controls at the Wastewater Treatment Plant. Equipment to be installed has been purchased. The influent pumps provide critical function to the plant as they pump all flow uphill to the trickling filters for treatment. The contractor shall, before any work is accepted by Macon Municipal Utilities, remove from the job site all litter and trash of any kind, and shall leave the area in good condition and ready for its use.
